LUTHERAN WORLD RELIEF OF FAITH LUTHERAN CHURCH

The Sewing Saints make quilts, kits for children's school supplies, items for care of babies, and kits for personal hygiene. We now, at the end of 2022, need less than 75 quilts to make our 6,000th quilt!

We honor the memory of our church's loved ones and special friends of Faith and those for whom our pastors gave memorial services who passed away this year. These memorial quilts were displayed in the sanctuary during the quilt Sundays in April and November. They were in memory of Richard Adamson, Doris Auseth, Linda Cargill, Julie Gentle, Rick Gibson, Guy Lusignan, Ron McMullen, and Barby Pyle. These quilts, along with others the quilters made, were sent on to Lutheran World Relief.

The total items we sent to Lutheran World Relief this year included 92 quilts, 54 school kits, and 34 baby kits. We drive these to an ingathering in Seattle where they are loaded into large semi-truck trailers. These then are taken to Baltimore, Maryland where they are stored in a huge warehouse and then the supplies are sent throughout the world as needed after disasters or areas of extreme poverty. We also gave two quilts for new local households of Habitat for Humanity.

Our income this year included donations from the Faith Lutheran Church Women of \$3,000, individual congregation members totaling \$2,316, and 89 cents bank interest. Our expenses included \$1,278.89 in sewing machine warranty, service, and supplies, \$647.10 shipping, \$254.00 quilt batting, \$359.54 for baby kit supplies, \$255.48 for school kit supplies, and \$28.40 for personal care kit supplies.

Thanks to all of you who provided material and financial help and the labor necessary to make all these quilts and kits. These are greatly appreciated by the recipients who are in tremendous need throughout the world.

GRIEF SUPPORT AND CARE

Our ministry of "Grief Support and Care" has continued to grow in 2022, both in the number of participants in the ministry, and also in the community of "companioning care" that has developed over the past three years. The primary focus of this ministry has been two provide two 12 week seminars entitled "Reconciling Life's Losses". These sessions seek to address the complex needs people experience in the painful losses of grief. They also have helped participants in the journey of mourning. embrace and express their pain with a trusted, empathetic circle of friends. When people learn to mourn well, they find, by God's grace, the healing power to re-integrate these experiences in a way that restores hope, joy, and purpose to life.

The course was developed by Dr Alan Wolfelt from the Center for Loss and Life Transitions in Ft. Collins, Colorado. Dr. Wolfelt pioneered an approach to grief called "Companioning Care for the Bereaved". His book, "Understanding Your Grief - Ten Essential Touchstones for Finding Hope and Healing Your Heart", and the accompanying Journal, form the basic content on which the messages and discussion groups of the meetings are shaped. Our gatherings have been both in person at the church, and online through Zoom. The Spring session had 16 registrants and the Fall had 22, with growth continuing throughout each series.

This past summer, between the Spring and Fall sessions, many from the program continued to meet in a weekly support group setting at the church. These sessions offered follow up help and care to one another on the journey through the wilderness of grief. This past summer I also returned to Ft. Collins for a week of training from the Wolfelt Center on "Becoming a More Effective Grief Educator".

As most of you are probably aware by now, my wife, Doris, and I will be gone for the months of March through May to serve as volunteers at a Guest House connected to Bethlehem Bible College in Palestine. We will not be able, of course, to facilitate a new seminar again at Faith Lutheran until next Fall. In the meantime, however, the grief ministry will continue to meet on Thursday afternoons in a support group mode. Four individuals who have served as discussion group leaders this Fall will continue to facilitate the meetings. Pastor Doug and Pastor Brenda will also be available to provide oversight and care to the ministry.

It has been truly an honor and joy to work as a part of the pastoral care team of Faith Lutheran, together with Pastor Doug, Pastor Brenda, and Mike Barnes, Youth Director. It has been a special joy to both Doris and myself to serve this marvelous congregation in whatever capacity was needed. In addition to these ministries, I have been privileged to serve in several other venues in the community on behalf of our congregation. One day a week has been spent as a volunteer chaplain at Mason General Hospital. I have also served on the Community Lifeline Board of Directors, and the Critical Incident Stress Management team for Mason County. This fall I was asked to be a grief counselor as a part of a newly formed team for the Shelton School District Employee Assistance Program. As part of that program a recorded interview was made to explain some of the dynamics of grief and how to

DOMINICAN REPUBLIC SCHOOL MINISTRY

We are very grateful for the support of Faith Lutheran Church and our faithful sponsors during this past year. Much has been accomplished to enable these children to move out of poverty. The following is a summary of your accomplishment:

In the spring you provided a suitcase full of shoes. With the help of Chriss and Brian Brickert on site at the Dominican Joe's School we managed donations of \$2,504 for the following:

- ◆ Kid's swing
- Classroom fans
- Basket ball hoop
- Security camera system
- Gravel
- Library construction
- Misc Playground equipment, learning tools

This fall you provided \$250 for uniform replacement. You also delivered a suitcase full of shoes, socks, and underwear.

We now have collected 2022-23 funding for 18 children at \$350 each. We are in the process of transferring \$6,300 for schooling costs.

You have also been supporting children from the Niños del Reino school. Our hearts go out to these poorest of the poor, mostly Haitians children. However, because this school only provides to the 4th grade, we feel it does not solve the problem of moving them out of poverty. We will continue to support the few children (3) that we have remaining there; however, will not be adding any additional. We have however been providing ongoing funds for their lunch program.

We feel that it is important for us to note that 100% of your donations are going to this ministry. No one within the Dominican Joe's foundation or our local support (Lidia) takes a salary.

On behalf of the kids I will like to thank Faith Lutheran for all their help and support to our school, thank you for your friendship and I'm sure we will continue to work together for the future of our school to continue growing helping the most needed with their education. FAITH LUTHERAN CHURCH ANNUAL CONGREGATIONAL MEETING MINUTES JANUARY 30, 2022

Call to Order: The meeting was called to order by President Andrea Miller at 11:20 a.m.

Opening Prayer: Rev. Dr. Doug Peterson, Lead Pastor

Establish Quorum: The secretary confirmed the required quorum had been established.

Approval of 2021 Minutes: Ron McMullen moved and John Butler seconded that the minutes be approved. Motion passed.

Financial Report: Eric Barkman, Treasurer, presented the 2021 financial report. The year ended with a cash flow of \$1,656. Mortgage contributions and payments of \$78,507 were made and the mortgage balance going in to 2022 is \$66,853.

2022 Budget: Eric Barkman, Treasurer, presented the 2022 Annual Budget of \$422,014. He pointed out the basic difference between the 2021 and 2022 budgets is due to the hiring of a full time Director of Children and Youth Ministries.

Presentation of Proposed Mission/Vision Statement: Pastor Doug Peterson presented the Vision/ Mission/Values Statement and thanked those who worked to refine it from the draft Council created last August.

Ballot and Voting Process: President Miller explained the voting process. Ballots had been handed out as members entered the sanctuary. Members voted; ballots were collected. Results, including Zoom, will be announced via email Tuesday, February 1, 2022.

Recognition and Thanks of the Faith Lutheran Church Women's Organization: Pastor Doug Peterson expressed appreciation to the church women for their contribution of time, effort and funds over the past decades. The FLCW disbanded at the close of 2021.

Recognition of Outgoing Council and Committee Members: Pastor Doug Peterson thanked President, Andrea Miller for her outstanding contribution during her two-year term. She received a standing ovation. Andrea shared appreciation to outgoing Council member Bert Woods, as well as those who resigned during the year-Brad Riggs and Kiki Rathburn.

Benediction: Rev. Brenda Satrum, Spiritual Formation Pastor

Adjournment: In his closing remarks, Council President Nominee, Eric Barkman, congratulated Pastor Doug on being voted Best Pastor/Priest in South Mason County for the year 2021. A motion was made to adjourn the meeting; Bert Woods moved, and Richard Knight seconded the motion. The meeting was adjourned at 11:47 a.m.

Addendum: The official count listed 72 in-person participants and 12 members participating via Zoom. All four items on the ballot were approved.

- 1. Roof

As most of you know, 2022 was an eventful year for me personally. Beth and I moved across the country, I began a new job working for Faith Lutheran, and our family dealt with many ups and downs related to Beth's health journey. We have been so grateful for the support that we've received from everyone since the moment we joined this community. Because of this roller coaster of a year, I have not been able to commit as fully to this job as I had hoped, but I am still pleased with what we accomplished in the past year.

COUNCIL PRESIDENT'S REPORT

Dear Faith Lutheran Members:

I have been blessed to be a member at Faith Lutheran Church for over 20 years. This is my second time serving on the Church Council, and first as Council President. The church office has seen changes this year, too. Bookkeeper Karyn Challender took a position elsewhere, but Connie Himlie has ably stepped in to help manage the books. She, along with Bev Robert and Barbie Nesmith, also have the office running smoothly and welcoming strangers and friends during office hours.

It was good to have the entire congregation rally together to put on the biggest and best Holiday Bazaar at Faith in years. Lefse, lefse, lefse! Over \$7000 was raised to support local missions and ministries.

Community theatre is back at Faith, post-COVID. "Faith Acts" is now "Connection Street Theatre." Michelle Whittaker directed a production of "A Christmas Carol" this fall, and plans are underway for "The Pirates of Penzance" in the spring of 2023.

Faith is blessed to be able to partner with several community organizations. The Kid's Cove Preschool is enjoying another year on our campus, as did Brighter Days. In the fall we welcomed CIELO, a non-profit agency that works with immigrants from Central America.

As is always the case, it seems, 2023 will bring new challenges, blessings, and transitions. Mike and Terry will be leaving the staff to pursue other projects and priorities. We'll need to replace the roof over the Fellowship Hall in the next year or so (and PAY for it!).
